REPEATER ISSUE

Chief McDavid informed Council the repeater to the radio system was destroyed by lightening some time ago. This issue is a danger to his officers, by not being able to have radio contact. He asked the council to replace the repeater at a cost of approximately \$4,125.00. B & C Communications also recommended relocate with a higher tower.
